Reducing Old-Age Social Exclusion (ROSEnet)

CALL FOR APPLICATIONS

Helsinki, Finland

17th - 20th January 2017

The training school is connected to COST action ROSEnet, which aims to overcome fragmentation and critical gaps in conceptual innovation on old-age exclusion across the life course, in order to address the research-policy disconnect and tackle social exclusion amongst older people in Europe. The action will engage with researchers and policy stakeholders to develop shared understandings and to direct the development of new policy and practice interventions, that can be practically and effectively implemented, for reducing exclusion in diverse European ageing societies. The Action will establish an innovative participatory, interdisciplinary and cross-European collaboration that will: (1) synthesise existing knowledge; (2) critically investigate the construction of life-course old-age exclusion (3) assess the implications of old-age exclusion across the life course; (4) Develop new conceptual frameworks on old-age exclusion; and (5) identify innovative, and implementable, policy and practice for reducing oldage exclusion. The Action focuses on economic, social, service, civic rights, and community/spatial exclusion. With deliverables that include conferences, workshop-policy events, briefing papers, early-career investigator development, and a repository of innovative practice and policy, the Action will forge much_needed new links between research and policy, enhancing evidence-based and effective innovation.

In order to meet these aims and especially the aim of early-career investigator development, a total of 4 Training Schools (TS) will be organised throughout the duration of the Action (one per grant period (May – April each year).

Preliminary programme of the 2017 Training School

We are happy to announce that the first Training School will take place in Helsinki, Finland from 17th to 20th January 2017. The theme of this Training School is the relative nature of exclusion. The lectures and discussions focus on the contextual elements of exclusion, including different welfare states and different socio-cultural contexts/environments. Additionally, methods of knowledge synthesis will be discussed. A detailed schedule of the TS program will be sent to the successful applicants, closer to the event. They cover a wide range of disciplines and methodological approaches. Each trainer will provide material, which will be disseminated in advance to participants.

Who can apply

COST training schools are mainly aimed at PhD students and early career investigators (ECI)¹, although more senior academics, researchers and policy-makers may also apply. Priority will be given to ECIs. The Training Schools are also open to the Action members. See the COST Vademecum for full details: http://www.cost.eu/

Eligible for financial support:

- 1. Trainees from COST member countries:
- 2. Trainees from approved NNC (near neighbour countries) institutions;
- 3. Trainees from approved European RTD Organisations.

¹ For COST, this includes people who have received a PhD within the past 8 years.



Financial support for trainees

Successful applicants may be eligible to apply for financial support through the COST Action. There are 10 grants available for trainees. The size of these grants can vary depending on the country of origin, although no individual grant can exceed the normal reimbursement rates of COST (see below). Applicants who intend to request financial support are invited to indicate this on their application form. The Management Committee (MC) of the Action decides the financial contribution for Trainees attending a TS. This decision is based on the following rules:

- The reimbursement rate per day is EUR 160 maximum;
- Up to EUR 300 may be attributed for travel expenses;
- A maximum grant of EUR 1 500 can be awarded;
- Grants for trainees can vary depending on the country of the Trainees (e.g. domestic, near or far countries).

Please note that trainee Grants do not necessarily cover all expenses related to attending the Training School. The Trainee Grant is a contribution to the overall travel, accommodation and meal expenses of the Grantee.

Prior to the Training School, all Trainees must register on e-COST

Trainees who are self-funded are also welcome to apply to attend the Training School.

Language skills

Unless otherwise indicated, all the modules will take place in English and the ability to speak, read and write fluently in this language is an absolute requirement for participation.

How to apply

Participation in all COST Training schools is subject to a selective application process.
